Terms and Conditions

PROMOTIONAL PERIOD

1. The NBA Singlet giveaway commences on 14/05/2017 and concludes 18/06/2017.
2. The prize draw will take place at The Glasshouse, Caulfield on 18/06/2017 or an earlier date, as notified by the Promoter where the NBA Finals conclude prior to the date.

ELIGIBILITY

3. In order to participate in the Promotion patrons must not have been excluded (whether self or otherwise).
4. By entering or participating in the Promotion each eligible participant agrees to abide by these terms and conditions.

ENTRY VIA IN VENUE CASH PURCHASES

6. Patrons will receive 1 official entry into the Promotion each time they make a food or beverage purchase of any value during a live NBA match during the promotional period in the sports bar at The Glasshouse, Caulfield.

All entries will be given to the customer at time of purchase in the sports bar, if the patron wishes to go in the draw they will need to write their name and contact phone number and present to the staff who will place the ticket in the draw. It is the patron's responsibility to present the ticket to the staff, and the promoter is under no responsibility to enter patrons into the draw where they have fail to abide by this entry mechanic.

THE PRIZE OR PRIZES TO BE WON
